TUITION & EXPENSES EFFECTIVE JULY 2018

The application fee is due at the time the application is submitted. After notification of acceptance eligibility, Bachelor of Science in Nursing (BSN) students are required to pay a nonrefundable background check, fingerprint and drug screening fee, which must be completed prior to registration. Graduate students in the Doctor of Nursing Practice and Master of Science in Nursing programs, as well as those in the Nursing Certificate programs that have practicums, may be required to pay a nonrefundable background check, fingerprint and drug screening fee prior to beginning their practicum coursework. Additional fees may apply depending on State Board of Nursing and practicum site requirements.

Tuition and expenses are calculated each session and are subject to change. Application for financial assistance does not negate the student's responsibility to ensure that arrangements for full payment of tuition and expenses are made before the first day of classes. A financial statement provided each session outlines the charges and the balance due. Please refer to **chamberlain.edu/tuition** for the most updated information on tuition and expenses.

Transportation to off-campus clinical/practicum facilities, meals at off-campus clinical/practicum facilities, healthcare insurance and personal expenses, including housing, are not included in the calculation of annual student costs. These expenses will vary according to individual student needs.

Full payment of all tuition and expenses is to be made before the first day of classes unless other arrangements have been made. The financial obligation for each session must be met in order to register for a subsequent session. Unusual circumstances or a financial crisis should be reported to student services immediately so that the University can assist the student in planning or determining if possible alternatives exist.

Chamberlain reserves the right to change tuition and expenses as necessary. Written notice of planned tuition and expenses changes will be posted in advance.

Cancellation Policy

The application fee is refundable if applicants cancel their application within 10 business days of submitting the application. A student who does not report to the first day of class and wishes to cancel the class may request a refund of any money paid over and above the application fee and applicable background check, fingerprint and drug screening fee. For students residing in the state of Tennessee enrolled prior to July 2018, students residing in Washington, and students residing in California or Minnesota seeking to obtain a certificate in public health nursing from the CA or MN Board of Nursing, student tuition is assessed at \$590 per credit hour for 25 nursing credit hours.
