



TUITION & EXPENSES EFFECTIVE MAY 2019

The application fee is due at the time the application is submitted. Students in the Master of Public Health and Master of Social Work degree programs that have practicums/fieldwork, may be required to pay a nonrefundable background check and drug screening fee, prior to beginning their practicum/fieldwork coursework. Additional fees may apply.

Tuition and expenses are calculated each session and are subject to change. Application for financial assistance does not negate the student's responsibility to ensure that arrangements for full payment of tuition and expenses are made before the first day of classes. A financial statement provided each session, outlines the charges and the balance due. Please refer to chamberlain.edu/tuition for the most updated information on tuition and expenses.

Transportation to off-campus practicum/fieldwork facilities, meals at practicum/fieldwork facilities, healthcare insurance and personal expenses, including housing, are not included in the calculation of annual student costs. These expenses will vary according to individual student needs.

Full payment of all tuition and expenses is to be made before the first day of classes, unless other arrangements have been made. The financial obligation for each session must be met in order to register for a subsequent session. Unusual circumstances or a financial crisis should be reported to student services immediately so the University can assist the student in planning or determining if possible alternatives exist.

Chamberlain University reserves the right to change tuition and expenses as necessary. Written notice of planned tuition and expenses changes will be posted in advance.

Cancellation Policy

The application fee is refundable if applicants cancel their application within ten (10) business days of submitting the application. A student that does not report to the first day of class and wishes to cancel the class, may request a refund of any money paid over and above the application fee and applicable background check and drug screening fee.  3. Effective August 13, 2018, discharge status must not be dishonorable, bad conduct or uncharacterized.
 4. An estimated \$150 fee (\$180 for New York), which can vary by state, is required for all MSW students prior to enrolling and includes a background and fingerprint check. All programs are subject to additional background, fingerprint, and/or drug screen clearance based on state or clinical/ practicum/ fieldwork site requirements.
 5. Students are responsible for their travel costs while participating in the immersion experience as part of MSW-505 and MSW-512. Typical costs include travel to/from Illinois, lodging and meals for 2-3 nights.
